MEMORANDUM OF ASSOCIATION
OF
KHOBSURAT LIMITED

- I. The name of the Company is KHOBSURAT LIMITED.
- II. The Registered Office of the Company will be situated in the State of West Bengal.
- III. The objects for which the Company is established are:
 - A. MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON IT'S INCORPORATION ARE.**
 1. To carry on In all their respective branches the business of manufacturing of and dealers in organic and in- organic chemicals of any nature and kind whatsoever and as wholesale and retail chemists and druggists, analytical chemists, drysalters, oil and colour men, importers exporters and manufacturers of and dealers In heavy, fine and all varieties of chemicals and chemical products. alkalis, acids, drugs, tanins, essences, pesticides, weedicides, Insecticides, caustic soda, soda ash, carbons, hydrocarbons, petro chemicals and petroleum products, alum, oleum, dyes and Intermediates, synthetic, rubber chemcris and rubber goods, agro- chemicals, marine-chemicals, phyte-chemicals, synthetic fibres, gas & gaseous materials' of all kinds, salts, marine minerals, their derivatives by-products and compounds of all kinds and description.
 2. To carry on the business of manufacturers, importers, exporters of and dealers in fertilizers, including synthetic and other fertilizers, manures, dips, sprays, medicines and remedies of all kinds for agricultural, horticultural or other purposes and remedies for animals.
 3. To promote industrial projects, industrial ventures, enterprises, to survey, investigate, assess, examine, ascertain, technical, commercial and financial feasibility of and undertake manufacturing and marketing of any plants, machineries, components, tools, Implements, accessories, articles, goods and things covered under foregoing paragraphs.

4. To carry on the business as traders, dealers, wholesalers, retailers, combers, scourers, spinners, weavers, knitters, finishers, dyers and manufacturers of yarns and fabrics, synthetics, cotton, silk, rayon, nylon, wool and other natural synthetics and/or fibrous substances Including staple fibre, polyester, polyacrylonitrile, polyvinyl acetate, elastomers and resins of all types, grades and copolymer formulations and forms or as processed goods including polythelene, polystyrene, chloride, polymethyl methacrylate, epoxy resins, alkyd resins, melamine, polycarbonates, polyamides or any other or new substances being improvements upon, modification of or being derived from additions to petro-chemicals or other products or resulting from any process and/or manufacture of materials from the waste realised from the above mentioned products either on its own account or on commission.
5. To carry on the business of spinners, weavers, manufacturers, balers, pressers traders, dealers, wholesalers, retailers, combers, Scourers, finishers and dyers, bleachers of jute, jute cuttings, jute rejections, hemp and any other, fibrous material and the cultivation thereof and the business of buyers, sellers and dealers of jute, jute cuttings, Jute rejections, hemp and any other fibrous material and of goods or merchandise made thereof.
6. To carry on the business of an investment company and to invest in acquire, sell, transfer, subscribe, for, hold and otherwise deal in and Invest in any shares, bonds, stocks, obligations issued or guaranteed by any company or companies constituted and carrying on business In India or elsewhere and debentures, debenture-stocks, bonds, obligations and securities issued or guaranteed by any Government State, Sovereign Commissioners Central or Provincial public body or authority supreme, municipal, local otherwise whether in India or elsewhere and to promote, form or acquire any company and to take, purchase or acquire shares or interest in any company and to transfer to any such company and property of this company either out of its own fund or out of funds that it might borrow.

B. OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF MAIN OBJECTS

1. To search for and secure openings for the employment of capital to carry on all kinds of promotion and agency business, and in particular to form constitute, float, lend money to, assist and control any companies, associations or undertakings whatsoever.
2. To borrow or raise or secure the payment of money in such manner and on such terms and with such rights, powers, and privileges as may be thought fit and determined from time to time in particular by the issue or sales of any debenture, debenture-stock, bonds, bills of exchange, promissory notes or other obligations or securities of the company, with full power to make the same transferable by delivery or by instrument of transfer or otherwise and either perpetual or terminable and either redeemable or otherwise and to charge or secure the same by Trust Deed or otherwise on the understanding of the company or upon any specific property and rights, present or future of the company and to devote any money so raised to any of the objects of the company upon such terms and conditions as may mutually be arranged.
3. Subject to the provisions of the Act and directions issued by Reserve Bank of India to receive money, deposits on interest or otherwise and to lend money and negotiate loans with or without security to such companies, firms or persons, and on such terms as may seem expedient and to guarantee the performance of contracts by any person, Companies or firms provided the company shall not carry on the business of banking.
4. To enter into, make and perform contracts of every kind and description, agreements and arrangements with any person, firm, association, corporation, municipality, country, state, body or Government or dependency thereof.
5. To carry on any other business (whether manufacturing or otherwise) which may seem to the company capable of being conveniently carried on in conjunction with the company's objects or which may be

advisable to undertake with a view to developing, rendering, valuable, prospecting or turning to account any property real or personal, belonging to other company or in which the company may be interested.

6. To buy, sell, exchange, alter, improve, manipulate, prepare for market and otherwise deal in all kinds of plant, machinery, apparatus, tools, utensils, receptacles, substances, materials, articles; and things necessary or convenient for carrying on any of the business or processes of the company usually dealt in by persons engaged in the like business or processes.
7. To buy, sell, manufacture, refine, manipulate, import and deal in substances, apparatus and things capable of being used in any business of the company.
8. To repair, alter, remodel, clean, renovate, convert, manipulate and prepare for re-sale any goods from time to time belonging to the company.
9. To adopt such means of making known and advertising the business and products of the Company as may seem expedient.
10. To manufacture for the purposes of the company, drums, barrels, packages, tanks and containers of every description from steel, iron and other metals and of such substances like wood, paper, boards, plastics, as may furnish materials for such manufacturing in any of its branches.
11. To employ experts to investigate and examine into the conditions, prospects, value, character and circumstances of any business concern and undertaking and generally of any assets, property or right including that of the company.
12. To purchase, take on lease or license or in exchange, hire or otherwise any real and/or personal property and any rights or privileges which the company may think necessary and convenient for the purposes of its business or may enhance the value of any other property of the company and in particular, any land (freehold, leasehold or other tenure) building, casement, machinery, plant and stock-in-trade and on any such lands to erect buildings, factories, sheds, godowns or other structures for the works and purposes of the company and also for the residence and amenity of its employees, staff and other workmen and erect and install machinery and plant and other equipments deemed necessary or convenient or profitable for purposes of the company and either to retain any property to be acquired for the purposes of the company's business or to turn the same to account as may seem expedient.
13. To build, construct, maintain, enlarge, pull down, remove or replace, improve or develop and to work, manage and control any buildings, offices, factories, mills, foundries, refineries, furnaces, godowns, warehouses, shops, machinery, engines, railways, tramways, roadways or other means of transport, sidings, bridges, reservoirs, dams, watercourses, water systems, wharves, electrical works, gas works operated by any other kind of power and also such other machinery, equipment, conveyance indirectly to advance the interests of the Company and to subsidise, contribute to or otherwise assist or take part in doing any of these things and/or to joint with any Government or Government authority in doing any of the above things.
14. To sink wells and shafts and to make, build and construct, lay down and maintain reservoirs, waterworks, cisterns, culverts, filter beds, main and other pipes and appliances and to execute and do all other works and things necessary or convenient for containing, storing, selling, delivering, measuring and distributing water for the purposes of the Company.
15. To let on lease or on hire-purchase system or to lend or otherwise dispose of any property belonging to the Company and to finance the purchase of any article or articles, made by the Company, by way of loans or

by the purchase of any such article or articles, and the letting thereof on the hire-purchase system or otherwise howsoever.

16. To sell, lease, mortgage, grant, licences, easements and other rights over and in any other manner whatsoever to transfer, deal with or dispose of the undertaking, property, assets, rights and effects of the company or any part thereof for such consideration as the company may think fit and in particular for shares, stocks, debentures or other securities of any company whether or not having objects altogether or in part similar to those of the company.
17. Subject to the provision of Section 391 of the Companies Act, 1956 to amalgamate, enter into partnership or into any arrangements for sharing profits. union of interests, co-operation, joint venture or reciprocal concession with any person firm or company carrying on or engaged in or about to carry on or engage in any business or transaction which the company is authorised to carry on or engage in, or which can be carried on In conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company.
18. To purchase or otherwise acquire and undertake the whole or any part of the business, property rights and liabilities of any person, firm or company, carrying on or proposing to carry on any business which this company is authorised to carry on or possessed of property or rights suitable for any of the company or which can be carried on In conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company and to purchase, acquire, sell and deal in property, share, stock, debenture stock of any person, firm or company and to conduct, take or to carry Into effect any arrangements In regard to the winding up of the business of any such person, firm or company.
19. To establish or promote or concur or be interested in establishing or promoting any company or companies for the purpose of acquiring all or any of the property, rights and liabilities of the company or for any other purpose whatsoever and to transfer to any such company any property of the company and to place or guarantee the placing of, underwrite, subscribe for or otherwise acquire all or any part of the shares, debentures or other securities of any such other company and to subsidise or otherwise assist any such other company.
20. To pay for any rights or property acquired by the company and to remunerate any person or company whether by cash payments or by department of shares, debentures or other securities of the company credited as paid up in full or in part or otherwise.
21. To acquire, hold, renew, use, sell, assign, lease, grant licences, mortgage, pledge or otherwise dispose of in any part of the world any patents, patent rights, designs, licences and privileges. Inventions, Improvements and processes, copy-right, trademarks, trade names, concessions, formulas, brevets 'd' invention, designs and the like converting any exclusive or non-exclusive or limited right to their use or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the company or the acquisition of which may seem calculated directly or Indirectly to benefit the company and to use, exercise, develop or grant licences in respect of or otherwise turn to account the property. right or information so acquired and to expend money in experimenting upon, testing or Improving any such patents, Inventions or rights.
22. To acquire, hold, use, sell, assign, lease, grant any contracts or concessions for or in relations to the supply and sale of any minerals, metals, product or other substances, materials, articles or things or equipment for or in relation to the construction, execution, carrying out, Improvement, management, administration or control of any works and conveniences required for the purpose of carrying out any of the business which the company is entitled to carry on and to undertake, execute, carry out, dispose of or otherwise turn to account such contracts or concessions.

23. To enter into any arrangement with any Government or authority, central, state, local or foreign or public body or person or firm or any private Individual that may seem conducive to the company's objects or any of them and to obtain from any such Government, authority, person or company any concessions, grants, decrees, rights, charters, contracts, licences, powers and privileges, whatsoever which may seem to the company capable of being turned to account or which the company may think directly or indirectly conducive to any of its objects or capable of being carried on In connection with Its business and to work, develop, carry out, exercise and turn to account the same.
24. To apply for, promote and obtain any act of Parliament, charter, privileges, concession, license or authorisation of any Government, State or municipality provisional order or license of any authority for enabling the company to carry any of its objects into effect or for extending any of the powers of the company or for effecting any modification of the constitution of the company or for any other purpose which may seem expedient and to oppose any proceedings or applications which may seem calculated, directly or indirectly to prejudice the Interests of the company.
25. To establish, maintain and conduct training schools, courses and programmes In connection with the Installation, use, sale, maintenance, Improvement or repair of machines, apparatus, appliances or products and of articles required In the use therefor used in connection therewith by the company and establish, provide, maintain and conduct or otherwise subsidise research laboratories and experimental workshops for scientific and technical research and experiments and to carry on with all scientific and technical researches experiments and tests of all kinds and to promote studies and research, both scientific and technical, Investigations and Inventions by providing, subsidising, endowing and assisting laboratories, workshops, libraries, meetings and conferences and by providing for the remuneration of scientific or technical professors or teachers and by providing for the award or exhibitions, scholarships, prizes and grants to students or otherwise and generally to encourage, promote and reward studies, research, Investigations, experiments, tests and Inventions of any kind that may be considered likely to assist any of the business which the company is authorised to carry on.
26. To acquire from any person, firm or body corporate whether In India or elsewhere technical Information, know-how processes, engineering, manufacturing and operating data plans, lay outs and blue prints useful for the design, erection and operation of plant required for any of the business of the Company and to acquire any grant or licence and other rights and benefits in the foregoing matters and things.
27. To make donations to such persons or institutions of cash or any other assets as may be thought directly conducive to any of the company's objects or otherwise expedient and in particular to remunerate any person or corporation Introducing business to this company and also to subscribe, contribute or otherwise assist or guarantee money for charitable, scientific, religious or benevolent objects or for any exhibition or for any public, general or other objects provided that provision of section 293A will apply.
28. To establish and maintain or procure the establishment and maintenance of any contributory or non-contributory provident, pension or superannuation funds for the benefit of and given or procure the giving of donations, gratuities, pensions, allowances or emoluments to any persons who are or were at any time in the employment or service of the company, or of any company, which is a subsidiary of the company or is allied to or associated with the company or with any such subsidiary company or who are or were at any time the directors or officers of the company or of any such other company as aforesaid and the wives, widows, families and dependents of any such persons and also establish and subsidise and subscribe to any institutions, associations, clubs or funds calculated to benefit or advance the interests and wellbeing of the company or of any such other company as aforesaid and make payments to or towards the Insurance of any such person as aforesaid and to any of the matters aforesaid either alone or in conjunction with any such other company as aforesaid.

29. To give to any officers, servants, or employees of the company any share or Interest In the profits of the company's business or any branch thereof and whether carried on by means or through the agency of any subsidiary company or not and for that purpose to enter Into any arrangements as the company may think fit.
30. To train or pay for the training In India or abroad of any of the Company's employees or any candidate in the interest of or for furtherance of the company's objects.
31. To provide residential and/or sleeping accommodating for workmen and others and to afford facilities and conveniences for washing, bathing, cooking, reading, writing and facilities for the purchase, sale and consumption of provisions, both liquid and solid and for the safe custody of goods for the welfare of the workmen and others.
32. To refer or agree to refer any claim, demand, dispute or any other question by or against the Company or in which the company is Interested and whether between the company and the members or his or their representatives or between the Company and third parties, to arbitration in India or at any place outside India and to observe and perform and to do all acts, deeds, matters and things to carry out or enforce the awards.
33. To pay out of the funds of the company all costs, charges and expenses which the company may lawfully pay with respect to the promotion, formation, and registration of the company and/or the Issue of its capital or which the Company shall consider to be preliminary including therein the cost of advertising, printing and stationery, commission for obtaining application for taking, placing or underwriting or procuring the underwriting of shares, debentures or other securities of the company and expenses attendant upon the formation of agencies, branches and local boards.
34. Upon any issue of shares, debentures or other securities of the company, to employ, brokers, commission agents and underwriters and to provide for the remuneration of such persons for their services by payments in cash or by the issue of shares, debentures or other securities of the company or by the granting of options to take the same or in any other manner allowed by law.
35. Subject to the provisions of the Act, to borrow or raise money, or to receive money on deposit or loan at interest or otherwise in such manner as the company may think fit and in particular by issue of debentures or debenture-stock (perpetual or otherwise) and convertible into shares of this or any other company or not and to secure the repayment of any such money borrowed raised or received, or owing by mortgage, pledge, charge or lien upon all or any of the property, assets or revenue of the company (both present & future) Including its uncalled capital, to give the lenders or creditors the power of sale and other powers as may seem expedient and to purchase, redeem or pay off any such securities and also by a similar mortgage, charge or lien to secure and guarantee the performance by the company or other persons, firm or company of any obligation undertaken by the company or any other person, firm or company as the case may be.
36. Subject to the provisions of the Act, to lend and advance money or to give credit to such persons or companies and on such terms as may seem expedient and in particular to customers and others having dealings with the company and to guarantee the performance of any contract or obligation and the payment of money of or by any such persons or companies and generally give guarantees and Indemnities but not amounting to banking.
37. To Invest and deal with the moneys for the purposes fo the company In such manner as may from time to time be determined.

38. To take or concur in taking all such steps and proceedings as may seem best calculated to uphold and support the credit of the company and to obtain and Justify public confidence and to avert or minimise financial disturbances which might affect the company.
39. To confer upon any encumbrancer or trustee for any encumbrances of uncalled capital such powers of making and enforcing calls and of voting the transfer of shares not fully paid up as may be thought fit.
40. To draw, make, accept, endorse, discount, execute and issue and negotiate bills of exchange, handles, bills of lading, promissory notes, warrant, debentures and other negotiable or transferable Instruments or securities.
41. To receive money on deposit with or without allowance of Interest thereon and to guarantee the debts and the contracts of customers, but not amounting to banking business as defined In Banking Regulations Act, 1949.
42. To subsidise, assist and guarantee the payment of money or for performance of any contract, engagement or obligation by any person or companies and in particular, customers of the company or any persons or companies with whom the company may have or Intend to have business relations.
43. 43. To vest any real or personal property, rights or interest acquired by or belonging to the company in any person or company on behalf of or for the benefit of the company and with or without any declared trust in favour of the company.
44. To act as agents or brokers and as trustees and to undertake and perform sub-contracts and to do all or any of the above thing in any part of the world and as principals, agents, contractors, trustees or otherwise and by or through agents, sub-contractors or trustees or otherwise and either alone or Joint with others.
45. To procure the Incorporation, registration or other recognition of the company in any country, state or place and to establish and regulate agencies for the purpose of the Company's business.
46. To sell or dispose of the undertaking of the company or any part thereof for such consideration as the company may think fit and in particular for shares, debentures, or securities of any other company having objects altogether or In part similar to those of the company
47. To distribute in specie or otherwise as may be resolved any property or assets of the company or any proceeds of sale or disposal of any property or assets of the company including the shares, debentures or other securities of any other company formed to take over the whole or any part of the assets or liabilities of the company, but so that no distribution amounting to a reduction of capital be made except with the sanction (if any) for the time being required by law.
48. To apply the assets of the company in any way in or towards the establishment, maintenance or extension of any association, Institution or fund for the protection of the interest of masters, owners and employers against loss by bad debts, strike, combinations, fire accidents or otherwise or for the benefits or any clerks, workmen or others at any time employed by the company or any of its predecessors in business or their families or dependents and whether or not in common with other persons or classes of persons and in particular of friendly co-operative and other societies, reading rooms, libraries, educational and charitable institutions, refractories, dining and recreation rooms, temples, schools and hospitals and to grant gratuities, pensions and allowances and to contribute to any funds raised by public or local subscription for any purpose whatsoever.

49. To carry on any business or branch of a business which this company is authorised to carry on by means or through the agency of any subsidiary company or companies and to enter into any arrangement with any such subsidiary company for taking the profits and bearing the losses of any business or branch so carried on, or for financing any subsidiary company or guaranteeing its facilities, or to make any other arrangements which may seem desirable with reference to any business or branch so carried on including power at any time either temporarily or permanently to close any such business or branch and to appoint directors or managers of any such subsidiary company.
50. To do all or any of the above things either as principals, agents, trustees, contractors or otherwise and either by or through agents, sub-contractors, trustees or otherwise and alone or in conjunction with others and to do all such things as are incidental or conducive to the attainment of the above objects.
51. To achieve greater growth of the National economy through increased productivity, effective utilization of materials and manpower resources, export promotion and continued application of modern techniques so as to discharge its social and moral responsibilities to the shareholders, employees, customers, local community and the society.
52. To accept gifts, bequests, devises and donations from members and others and to make gifts to members and others of money, assets and properties of any kind.
53.
 - i. To undertake, carry out, promote and sponsor rural development including any programme for promoting the social and economic welfare of or upliftment of the public or any rural area and to incur any expenditure on any programme or rural development, to assist execution and promotion thereof either directly or through an independent agency or in any other manner, and for this purpose, the directors may transfer and divert the ownership of any property to or in favour of any public or local body or authority or central or state Government etc.
 - ii. To undertake, carry out, promote and sponsor or assist any activity for the promotion and growth of national economy and for discharging what the directors may consider to be social and moral responsibilities of the company to the public or any section of the public as also any activity which the directors consider likely to promote national welfare or social, economic or moral upliftment of the public or any section of the public in such manner directors may think fit.

C. OTHER OBJECTS

1. To carry on business as producers, manufacturers, processors, converters, refiners, makers, bottlers, stockists, dealers, Importers, exporters traders, retailers, agents, buyers, or sellers of oxygen, acetylene, ammonia, nitrogen, hydrogen, coal gas, natural gas, helium and other types and kinds of gases, mineral, oil, motor and aviation spirit, diesel oil, kerosene, diverse hydrocarbon oils and their blends including synthetic, fuels and lubricating oils required for or used in industries, agriculture, space rockets and crafts and communications.
2. To carry on business as producers, importers, exporters, processors, manufacturers, buyers, sellers, distributors, stockists, agents and brokers of coal, coke, charcoal, lignite, petroleum, clay, salt, sodium chloride, calcium phosphate, nickel, beryllium, zinc, lead, asbestos, tin, alumina, mercury, silicon, sulphur, graphite, brass, aluminum, silica sand, betonies, corundum, manganese, mica, silver, gold, platinum, diamond, sapphire, ruby, topas, gamet, emerald, pearl and other precious semi-precious or commercial minerals and stones and to act as metal founders, manufacturers, agents and dealers of metals, sheets, wire, rods, squares, plates, metal foils pipes, tubes, Ingots, billets, circles parts, coils, utensils,

ornaments, decorative and art materials and jewelry made wholly or partly from any one or more of the metals and materials herein or their derivatives.

3. To carry on business as manufacturers, operators, dealers, distributors, stockists, buyers, sellers, repairers, cleaners, storers, Importers, exporters or agents of motor cars, trucks, forklifts, lorries and carriages, motor-cycles, mopeds, scooters, bicycles, tractors, earth-moving equipments trailers and other vehicles, aircrafts, ships and other vessels drawn by power, railway locomotives and rolling stock, agricultural machinery and Implements, pumps and machineries and spare parts, engines, motors, accessories, components, tools, ancillaries, batteries, glass panels and sheets, apparatus, fitting, furnishing materials, tyre, valves, paints, lubricants, fuel, carbon brushes, gas or other materials and to act as transporters of goods and passengers, travelling or clearing agents and to let out, hire or finance on hire purchase system or otherwise automobile and other vehicles, Implements, machines and any of the aforementioned products or thing.
4. To carry on business as manufacturers, processors, re-rollers, refiners, smelters, converters, producers, exporters, Importers, traders, dealers, distributors, stockists, buyers, sellers, agents or merchants in all kinds of form of ferrous and nonferrous metals, ferro alloys, iron and steel including mild, high carbon, spring, high speed, tool, alloy, stainless steels, iron metals and alloys, ingots, billets, bars, joists, rods, squares, structural, tubes, poles, pipes, sheets, castings, wires, rails, rolling materials, rollers, semi-manufacturers and other materials made wholly or partly of Iron, steel, alloys and metals required in or used for Industrial defense, agricultural, transport, commercial, domestic, building, power transmission, and/or construction purposes.
5. VII. TRANSFER AND TRANSMISSION OF SHARES

52. The Company shall keep a book called the "Register of Transfers" and herein shall be fairly and distinctly entered the particulars of every transfer or transmission of any share in the Company the provisions herein contained regarding transfers and transmissions shall be subject to the requirements of the said Act and other laws for the time being relating to transfers and transmissions of shares.
53. No transfer shall be registered unless a proper instrument of transfer (which share shall be in the form specified in the Rules) has been delivered to the Company. Every instrument of transfer shall be duly stamped and shall be executed by or on behalf of the transferor and the transferee and in the case of a share held by two or more holder or to be transferred to the joint names of two or more transferees by all such joint holders or by all such joint transferees as the case may be. Several executors or administrators of a deceased member proposing to transfer the share registered in the name of such deceased member shall all sign instrument of transfer in respect of the share as if they were the joint holder of the share. The instrument of transfer shall specify the name address and occupation if any of the transferee.
54. In the case of the death of any one or more of the persons named in the Register as the joint holders of any share the survivor or survivors shall be the only persons recognized by the Company as having any title to or interest in such share but nothing herein contained shall be taken to release the estate of the deceased joint holder from any liability on the shares held by him jointly with any other person.
55. i. On the death of a member, the survivor or survivors where the member was a joint holder, and his nominee or nominees or legal representatives where he was a sole holder, shall be the only persons recognized by the company as having any title to his interest in the shares.
- ii. Where there is no nominee, the executors or administrator of a deceased member and not being one of several joint holder shall be only persons recognized by the Company as having any title to the shares registered in the name of such deceased member and the Company shall not be bound to recognized such executor or administrators unless they shall have first obtained Probate or Letters of Administration or other legal representation as the case may be as provided in Article 2(m) nevertheless the Directors in any case where they in their absolute discretion think fit may dispense with the production of Probate or letters of Administration

or such other legal representation upon such terms as to indemnity or otherwise as they may claim fit and under the next Article register the name of any person claims to be absolutely entitled to the shares standing in the name of deceased member as a member in respect of such shares.

Every instrument of transfer duly executed in accordance with the provision of these Articles and duly stamped and dated shall be left at the office of the Company for registration accompanied by the certificate of the shares to be transferred or if no such certificate is in existence the letter of allotment and also such other evidence as the Directors may require to prove the title of the transfer or his right to transfer the shares and generally under and subject to such conditions and regulations the Directors shall from time to time prescribe. Where on an application in writing made to the Company by the transferee and bearing the stamp required for an instrument of transfer it is proved to the satisfaction of the Directors that an instrument of transfer signed by or on behalf of the transfer and by or on behalf of the transferee has been lost the Company may if the Directors think fit register the transfer on such terms as to indemnity as the Directors may think fit. B. No necessity for distinctive number for securities

Section 45 of the Act not to apply: Nothing contained in the Act or these Articles regarding the necessity of having distinctive number for securities issued by the Company shall apply to securities held in a depository.

C. Option for investors:

Every person subscribing to securities offered by the Company shall have the option to receive the security certificates or to hold the securities with a Depository. Such a person who is the beneficial owner of the securities can at any time opt out of a Depository if permitted by law in respect of any security in the manner provided by the Depositories Act and the Company shall in the manner and within the time prescribe issue to the beneficial owner the required certificate of securities.

Where a person opts to hold his security with a Depository the Company shall intimate such Depository the details of allotment of the security and on receipt of such information the Depository shall enter in its record the name of the allottee as the beneficial owner of the security.

D. Securities in Depositories to be in fungible form:

All securities held by a Depository shall be dematerialized and shall be in a fungible form. Nothing contained in Section 89 of the Act shall apply to a Depository in respect of the securities held by it on behalf of the beneficial owners.

E. Rights of Depositories and Beneficial Owners:

- i. Notwithstanding anything to the contrary contained in the Act or these Articles a Depository shall be deemed to be the registered owner for the purpose of effecting transfer of ownership of security on behalf of the beneficial owner.
- ii. Save as otherwise provided in (i) above the Depository as a registered owner of the securities shall not have any voting rights or any other right in respect of the securities held by it.
- iii. Every person holding securities of the Company and whose name is entered as a beneficial owner in the records of the Depository shall be a member of the Company. The beneficial owner of the securities shall be entitled to all the rights and benefits and be subject to all the liabilities in respect of his securities held by a Depository.

F. Depository to furnish information:

Notwithstanding anything to the contrary contained in the Act or these Articles where the securities are held in a Depository on the records of the beneficial ownership may be served by such Depository on the Company by means of electronic mode or by delivery external discs or drives.

G. Option to opt out in respect of any security:

If a beneficial owner seeks to opt out of a Depository in respect of any security the beneficial owner shall inform the Depository accordingly. The Depository shall on receipt of the intimation as above make appropriate entries in its record and shall inform the Company accordingly.

The Company shall within thirty (30) days of the receipt of intimation from the Depository and on fulfillment of such conditions and on payment of such fees as may be specified by the regulations issue the certificate of securities to the beneficial owner or the transferee as the case may be.

H. Section 56 of the Act not to apply:

Notwithstanding anything to the contrary contained in the Articles Section 56 of the Act shall not apply to transfer of security affected by the transferor and the transferee both of whom are entered as beneficial owner in the record of a Depository.

I. Register and index of beneficial owners:

The Register and index of Beneficial Owner maintained by a Depository under Section 11 of the Depositories Act shall be deemed to be the Register and Index of Members and security holders as the case may be for the purpose of these Articles.

J. Intimation to Depository:

Notwithstanding anything contained in the Act or these Articles where securities are dealt with in a Depository the Company shall intimate the details of allotment of securities thereof to the Depository immediately on allotment of such securities.

K. Stamp duty on securities held in dematerialized form:

No stamp duty would be payable on shares and securities held in dematerialized form in any medium as may be permitted by law including any form of electronic medium.

L. Applicability of the Depositories Act:

In case of transfer of shares debenture and other marketable securities where the Company has not issued any certificate and where such shares debenture or securities are being held in an electronic and fungible form in a Depository the provisions of the Depositories Act 1996 shall apply.

M. Company to recognize the rights of Registered Holders as also the Beneficial Owners in the records of the Depository :

Save as herein otherwise provided the Company shall be entitled to treat the person whose name appears on the Register of Members as the holder of any share as also the Beneficial Owner of the shares in records of the Depository as the absolute owner thereof as regards receipt of dividends or bonus or service of notice and all or any other matters connected with the Company and accordingly the Company shall not except as ordered by a Court of competent jurisdiction or as by law required be bound to recognize any benami trust or equity or equitable contingent or other claim to or interest in such share on the part of any other person whether or not it shall have express or implied notice thereof.

IX. INCREASE AND REORGANISATION OF CAPITAL

70. The Company may by Ordinary Resolution so after the condition of its Memorandum of Association as : Company may alter its capital in certain ways

- (a) to increase its share capital by such amount as it think expedient by issuing new shares;
 - (b) to consolidate and divide all or any of its share capital into shares of larger amount than its existing shares;
 - (c) to convert all or any of its fully paid-up shares into stock and re- covert that stock into fully paid-up shares of any denomination;
 - (d) to sub-divide its share or any of them into share of smaller amount than is fixed by its Memorandum of Association so however that in the sub-division the proportion between the amount paid and the amount if any unpaid on each reduced on each reduced shares shall be the same as it was in the case of the share from which the reduced share is derived.

 - (d) Where any such shares are redeemed otherwise than out of profits which would otherwise have been available for dividend be transferred to a Reserve Fund to be called 'The Capital Redemption Reserve Account' a sum equal to the nominal amount of the shares redeemed and the provisions of the Act relating to the reduction of the share capital of the Company shall except as provided under Section 55 of the Act, apply as if the capital Redemption Reserve Account were paid-up share capital of the Company.
 - (e) Whenever the Company redeems any redeemable preference shares the provisions of Section 64 of the Act shall be complied with.

Subject to the provisions of Section 55 of the Act and these Articles the redemption of preference shares hereunder may be affected in accordance with the terms and conditions of their issue and in the absence of any such terms and conditions in such manner as the Directors may think fit.

Where the Company has redeemed or is about to redeem any preference shares it shall have power to issue shares up to the nominal amount of

the shares redeemed or to be redeemed as if those shares had never been issued and accordingly the share capital of the Company shall not for the purpose of calculating the fees payable under Section 403 of the said Act be deemed to be increased by the issue of shares in pursuance of this clause. Provided that where new shares are issued before the redemption of the old shares the new shares shall not so far as relate to stamp duty be deemed to have been issued in pursuance of this clause unless the old shares are redeemed within one month after the issue of the new shares.

The capital Redemption Reserve Account may notwithstanding anything in this Article be applied by the Company in paying up unissued shares of the Company to be issued to members of the Company as fully paid bonus shares.

XI. MODIFICATION OF RIGHTS

81. - b) he has given the Company notice in writing of his unwillingness to be reappointed; or
- c) a special resolution has not been passed at that meeting appointing some other auditor or providing expressly that he shall not be reappointed;

 - i) he has been declared as “Willful Defaulter” as per definition

given in RBI directions/guidelines

155. I. Not less than two-thirds of the total number of Director (total number of Directors, shall not include independent directors, whether appointed under this act or any other law for the time being in force, on the Board of a Company) of the company shall-
- a) be persons whose period of office is liable to determination by retirement of Directors by rotation ; and
 - b) save as otherwise expressly provided in the said Act, be appointed by the Company in General Meeting.
- II. The remaining Directors of the Company shall, also be appointed by the Company in General Meetings except to the extent that the Articles otherwise provide or permit.
156. I. At every Annual General Meeting of the Company, one-third of such of the Directors for the time being as are liable to retire by rotation, or if their number is neither three nor a multiple of three, then, the number nearest to one-third, shall retire from office.
- II. The Directors to retire by rotation at every Annual General Meeting shall be those who have been longest in office since their last appointment, but as between persons who become Directors on the same day, those who are to retire by rotation shall, in default of and subject to any agreement among themselves, be determined by lot.
- III. A retiring Director shall be eligible for re-election and shall act as a Director upto and throughout the meeting at which he retires.
- IV. At the Annual General Meeting at which a Director retires as -
- a) aforesaid the company may fill up the vacancy by appointing the retiring Director or some other person thereto.
 - b) If the vacancy of the retiring director is not so filled-up and the meeting has not expressly resolved not to fill the vacancy, the meeting shall stand adjourned till the same day in the next week, at the time and place, or if that day is public holiday, till the next succeeding day which is not a public holiday, at the same time and place.
 - c) If at the adjourned meeting also, the vacancy of the retiring director is not filled up and that meeting also has not expressly resolved not to fill the vacancy, the retiring Director shall be deemed to have been re-appointed at the adjourned meeting unless-
 - i) at the meeting or at the previous meeting a resolution for the reappointing of such Director has been put to the meeting and lost;
 - ii) the retiring Director has, by a notice in writing addressed to the Company or its Board of Directors, expressed his unwillingness to be so re-appointed;
 - iii) he is not qualified or is disqualified for appointment;
 - iv) a resolution, whether special or ordinary, is required for his appointment or reappointment in virtue of any provisions of the said Act; or

v) Section 162 is applicable to the case or Article 160 (b) is applicable to the same.

157. The Company may at any Annual General Meeting fill up the office of any Director vacated during the previous year and not already filled up. Company may fill up a vacancy
158. A person who is not a Director retiring by rotation shall subject to the provisions of the said Act be eligible for appointment to the office Director at any General Meeting, if he, or some member intending to propose him as a director, has, not less than fourteen days before the meeting, left at Registered Office of the Company, a notice in writing under his hand signifying his candidature as a director or, as the case may be, the intention of such member to propose him as a candidate for that office, along with the deposit of one lakh rupees or such higher amount as may be prescribed which shall be refunded to such person or, as the case may be, to the member, if the person proposed gets elected as a director or gets more than twenty-five percent of total valid votes cast either on show of hands or on poll on such resolution. The company shall, at least seven days before the general meeting, inform its members of the candidature of a person for the office of a director or the intention of a member to propose such person as a candidate for the office, by serving individual notices, on the members through electronic mode to such members who have provided their email addresses to the Company for communication purposes, and in writing to all other members; and by placing notice of such candidature or intention on the website of the company. It shall not be necessary for the company to serve individual notices upon the members as aforesaid, if the Company advertises such candidature or intension, not less than seven days before the meeting at least once in a vernacular newspaper in the principal vernacular language of the district in which the registered office of the company is situated, and circulating in that district, and at least once in English language in an English newspaper circulating in that district. Notice of candidature when to be given
159. a) A person appointed as a director shall not act as a director unless he gives his consent to hold the office as director and such consent has been filed with the Registrar within thirty days of his appointment in manner prescribed in the rule 8 of the Companies (Appointment and Qualification of Directors) Rules, 2014. Consent of Director to be filed with the Company and Registrar
- b) A person other than-
- i) a Director reappointed after retirement by rotation or immediately on the expiry of his term of office, or
- ii) an additional or alternate Director or a person filling a casual vacancy in the office of a Director under Section 161 or Article 162 & 164 appointed as an additional or alternate Director immediately on the expiry of his term of office shall not act as a Director of the Company unless he has within thirty days of his appointment signed and filed with Registrar his consent in writing to act as such Director.
160. I. At a General Meeting of the Company, a motion for the appointment of two or more persons as directors of the Company by a single resolution shall not be moved unless a proposal to move such a motion has first been agreed to at the meeting without any vote being cast against it. Appointment of Directors to be voted on individually
- II. A resolution moved in contravention of clause (1) shall be void whether or not any objection was taken when it was moved.
- III. For the purpose of this Article a motion for approving a person for appointment, or for nominating a person for appointment as a director,

shall be treated as a motion for his appointment

161. The Directors shall have the power to appoint any person, other than a person who fails to get appointed as a director in a general meeting as an additional Director provided that the total number of Directors shall not thereby exceed the maximum number fixed by Article 148. Each such Additional Director shall hold the office up to the date of the next general meeting or last date, on which the annual general meeting should have been held, whichever is earlier. Directors may appoint additional Directors
162. I. If the office of any Director appointed by the Company in the General Meeting is vacated before his term of office expires in the normal course, the resulting casual vacancy may, be filled by the Board of Directors at a meeting of the Board.
- II. Any person so appointed shall hold office only up to the date up to which the Director in whose place he is appointed would have held office if it had not been vacated as aforesaid.
163. I. the Board of Directors of the company may, by a resolution passed by the Company in general meeting, appoint a person, not being a person holding any alternate directorship for any other director in the company, to act as an alternate director for a director during his absence for a period of not less than three months from India Appointment of Alternate Director
- II. No person shall be appointed as an alternate director for an independent director unless he is qualified to be appointed as an independent director under the provisions of this Act.
- III. An Alternate Director shall be entitled to notice of meetings of the Directors and to attend and vote thereat accordingly, but he shall not require any qualification whilst the Original Director holds the necessary qualification.
- IV. An Alternate Director shall not hold office as such for a period longer than that permissible to the Director in whose place he has been appointed and shall vacate the office if and when the Director in whose place he has been appointed returns to India.
- V. If the term of office of the Original Director is determined before he so returns to India, any provision for the automatic reappointment of retiring Directors in default of another appointment shall apply to the Original, and not to Alternate Director.
- VI. An Alternate Director may be removed by the Board of Directors which may appoint another Alternate Director in his place.
164. The continuing Director may Act notwithstanding any vacancy in their body but if and so long as their number is reduced below three the continuing Directors may act for the purpose of increasing the number of Directors to the said number or of summoning a General Meeting of the Company but for no other purpose. Directors may act notwithstanding vacancy

XX. VACATION OF OFFICE BY DIRECTORS

165. A Director may at any time resign from his office upon giving notice in writing to the Company of his intention to do so and thereupon his office shall be vacated. Resignation of Directors

A director may resign from his office by giving a notice in writing to the company and the Board shall on receipt of such notice take note of the same and the company shall intimate the Registrar in such manner, within such time and in such form prescribed in the said Act and shall also place the fact of such resignation in the report of directors laid in the immediately following general meeting by the company.

A director shall also forward a copy of his resignation along with detailed reasons for the resignation to the Registrar within thirty days of resignation in such manner as may be prescribed in the said Act.

The resignation of a director shall take effect from the date on which the notice is received by the company or the date, if any, specified by the director in the notice, whichever is later. The director who has resigned shall be liable even after his resignation for the offences which occurred during his tenure.

Where all the directors of a company resign from their offices, or vacate their offices under Section 167 of the said Act, the promoter or, in his absence, the Central Government shall appoint the required number of directors who shall hold office till the directors are appointed by the company in general meeting.

166. Subject to the provisions of Section 169 of the said Act the Company may, by Ordinary Resolution, remove a Director, not being a director appointed by the Tribunal under Section 242 of the said Act, before the expiry of the period of his office after giving him a reasonable opportunity of being heard. A vacancy created by the removal of a Director under this Article may be filled by the appointment of another Director in his stead in the manner provided in the said Section.
- Removal of Directors

Provided that a director may also be removed from his office if he has been identified as “Willful Defaulters” as per definition given in RBI directions/guidelines.

167. Subject to the provisions of Section 167 of the said Act the office of a Director shall become vacant if-
- Vacation of office by Directors
- (a) he incurs any of the disqualifications specified in Section 164 of the said Act.
 - (b) he absents himself from all the meetings of the Board of Directors held during a period of twelve months with or without seeking leave of absence of the Board.
 - (c) he acts in contravention of the provisions of Section 184 relating to entering into contracts or arrangements in which he is directly or indirectly interested;
 - (d) he fails to disclose his interest in any contract or arrangement in which he is directly or indirectly interested, in contravention of the provisions of Section 184;
 - (e) he becomes disqualified by an order of a court or the Tribunal;
 - (f) he is convicted by a court of any offence, whether involving moral turpitude or otherwise and sentenced in respect thereof to imprisonment for not less than six months. The office shall be vacated by the director even if he has filed an appeal against the order of such court;
 - (g) he is removed in pursuance of the provisions of this Act;
 - (h) he, having been appointed a director by virtue of his holding any office or other employment in the holding, subsidiary or associate company, ceases to hold such office or other employment in that company.

XXI. PROCEEDING OF DIRECTORS

168. The Company shall hold a minimum number of four meetings of its Board of Directors every year in such a manner that not more than one hundred and twenty days shall intervene between two consecutive meetings of the Board. Meeting of Directors
- The participation of directors in a meeting of the Board may be either in person or through video conferencing or other audio visual means, as may be prescribed, which are capable of recording and recognizing the participation of the directors and of recording and storing the proceedings of such meetings along with date and time.
- The Central Government may, by notification, specify such matters which shall not be dealt with in a meeting through video conferencing or other audio visual means.
169. Notice of every meeting of the Board Directors of the Company shall be given in writing to every Director for the time being in India and at his usual address in India to every other Director. Notice of meetings
- A meeting of the Board shall be called by giving not less than seven days' notice in writing to every director at his address registered with the company and such notice shall be sent by hand delivery or by post or by electronic means:
- Provided that a meeting of the Board may be called at shorter notice to transact urgent business subject to the condition that at least one independent director, if any, shall be present at the meeting:
- Provided further that in case of absence of independent directors from such a meeting of the Board, decisions taken at such a meeting shall be circulated to all the directors and shall be final only on ratification thereof by at least one independent director, if any
170. The quorum for a meeting of the Board shall be one-third of its total strength (any fraction contained in that one-third being rounded off as one) or two Directors whichever is higher and the participation of the Directors by video conferencing or by other audio visual means shall also be counted for the purpose of quorum as permitted by the applicable laws from time-to-time. Provided that where at any time the number of interested Directors exceed or is equal to two-thirds of the total strength the number of the remaining Directors that is to say the number of Directors who are not interested present at the meeting being not less than two shall be the quorum during such time. Quorum for meeting
- The expressions 'total strength' shall not include Directors whose places are vacant and 'interested Director' shall have the same meaning given in the Section 184 (2) of the said Act.
171. I. If meeting of Board could not be held for want a quorum then the meeting shall automatically stand adjourned till the next week at the same time and place or if that day is a national holiday till the next succeeding day, which is not a national holiday, at the same time and place. Procedure where meeting adjourned for want of Quorum
- II. The provisions of Article 169 shall not be deemed to have been contravened merely by reason of the fact that a meeting of the Board which had been called in compliance with the terms of that Article could not be held for want of a quorum.

XXII. DIRECTORS' DISQUALIFICATION

180. Any assignment of his office by a Director shall be void. Directors not to assign Office.
181. The Company shall not, directly or indirectly, advance any loan, including any loan represented by a book debt, or give any guarantee or provide any security in contravention of Sections 185 of the said Act. Loans to Directors, etc.
182. No Director or such other related party mentioned in Section 188 shall without the previous consent of the Company accorded by a special Resolution hold an office or place of profit in the Company or any subsidiary or associate Companies except within the limit as provided in the said Section. Provided that it shall be sufficient if the Special Resolution according the consent of the Company is passed at the General Meeting of the Company held for the first time after the holding of such office or place of profit. Director not to hold office of profit.
183. Subject to the restrictions imposed by Articles 182 and 183 and Sections 184 and 188 of the said Act and the observance and fulfillment thereof no Director shall be disqualified by his office from contracting with the Company either as vendor purchaser agent broker macadam or otherwise nor shall any such contract or any contract or arrangement entered into by or on behalf of the Company in which any Director shall be in any way interested be liable to account to the Company for any profit realized by any such contract or arrangement by reason only of such Director holding that office or of the fiduciary relation thereby established. Directors may contract with the Company
184. Every director shall at the first meeting of the Board in which he participates as a director and thereafter at the first meeting of the Board in every financial year or whenever there is any change in the disclosures already made, then at the first Board meeting held after such change, disclose his concern or interest in any company or companies or bodies corporate, firms, or other association of individuals which shall include the shareholding, in such manner as may be prescribed.

Every director of a company who is in any way, whether directly or indirectly, concerned or interested in a contract or arrangement or proposed contract or arrangement entered into or to be entered into with a body corporate in which such director or such director in association with any other director, holds more than two per cent. shareholding of that body corporate, or is a promoter, manager, Chief Executive Officer of that body corporate; or with a firm or other entity in which, such director is a partner, owner or member, as the case may be, shall disclose the nature of his concern or interest at the meeting of the Board in which the contract or arrangement is discussed and shall not participate

in such meeting.

Provided that where any director who is not so concerned or interested at the time of entering into such contract or arrangement, he shall, if he becomes concerned or interested after the contract or arrangement is entered into, disclose his concern or interest forthwith when he becomes concerned or interested or at the first meeting of the Board held after he becomes so concerned or interested.

185. A Director of the Company may be or become a Director of any company promoted by or a subsidiary of the Company or in which it may be interested as a vendor shareholder or otherwise and no such Director shall be accountable for any benefits received as Director or member of such Company. Directors may be Directors of Company promoted by the Company.

XXIII. BORROWING POWERS OF DIRECTORS

186. I. Subject to clause (2) hereof the Directors may from time to time at their discretion raise or borrow or secure the repayment of any sum or sums of money for the purpose of the Company from any persons firm or companies expressly including any member or Director of this Company. Any such moneys may be raised and the payment or this Company. Any such money may be raised and the payment or repayment of such moneys may be raised secured in such manner and the upon such terms and conditions in all respects as the Directors may think fit and in particular by receiving deposits and advances at interest with or without security or by the issue of debentures or debenture-stock of the Company charged upon all or any part of the property of the Company (both present and future) including its uncalled capital for the time being or by mortgaging, charging or pledging any lands buildings machinery, plant, goods, or other property and securities of the Company or by such other means as to them may seem expedient. Power to borrow
Condition on which money can be borrowed
- II. The Board of Directors shall not except with the consent of the Company by a Special Resolution in General Meeting borrow moneys where the moneys to be borrowed together with the moneys already borrowed by the Company (apart from temporary loans obtain from the Company's bankers in the ordinary course of business) will exceed the aggregate of the paid-up-capital of the Company and its free reserves that is to say reserves not set apart for any specific purpose. Every resolution of the consent of the Company in General Meeting shall specify the total amount upto which moneys may be borrowed by the Board of Directors. The expression 'temporary loans' means loans repayable on demand or within six months from the date the date of the loan such as short term cash credit arrangements the discounting of bills and the issue of other short-term loans of a seasonal character but does not includes loans raised for the purpose of a financing expenditure of a capital nature. No debt incurred by the Company in excess of the limit imposed by this Article shall be valid or effectual unless the lender proves that he advanced the loan in good faith and without knowledge that the limit imposed by this Article had been exceeded. Restrictions on borrowing powers of Board
- III. Any bonds debentures, debenture-stock or other securities issued or to be issued by the Company shall be under the control of the Directors who may issue them upon such terms and conditions and in such manner and for such conditions as they shall consider to be for the benefit of the

- Company.
- IV. Any such debentures, debenture-stock and other securities may be made assignable free from any equities between the Company and the person to whom the same may be issued.
- V. Any such debentures, debenture-stock bonds or other securities may be issued at a discount premium or other wise and on condition (with the consent of the Company in General Meeting save as provided in Article 74 that they may have a right to allotment of or be convertible into shares of any denominations and with any special privileges and condition as to redemption (or being irredeemable) surrender drawing, re-issue attending at General Meeting of the Company appointment of Directors and otherwise provided that no debentures debentures-stock bonds or other securities may be issued carrying voting rights.
- VI. The any offer is made to the public to subscribe for or purchase debentures the provisions of the said Act relating to a prospectus shall be complied with.
187. The Directors shall cause a proper register to be kept in accordance with the provisions of Section 85 and 88 of the said act of all mortgages debentures and charges and shall cause the requirements of Sections 71, 2(16) and 77 to 76 of the said Act in that behalf to be duly complied with so far as they are required to be complied with by the Directors.

XXIV. POWERS OF DIRECTORS

188. Subject to the provisions of Sections 179, 180, 181, 182, 184, 188, 196, and 203, of the said Act, the Board of Directors of the Company shall be entitled to exercise all such powers, give all such consents, make all such arrangements, and generally do all such acts and things as are or shall be, by the said Act, and the Memorandum of Association and these presents directed or authorized to be exercised, given, made or done by the Company, and are not thereby or hereby expressly directed or required to be exercised given made or done by the Company in General Meeting, but subject to such regulations (if any) being not inconsistent with the said provisions as from time to time may be prescribed by the Company in General Meeting, provided that no regulation so made by Company in General Meeting shall invalidate any prior act of the Directors which would have been valid if the regulation had not been made.
189. Save as provided by the said Act or by these presents and subject to the restrictions imposed by Section 179 and rules made thereunder of the said Act the Directors may delegate all or any powers by the said Act or by the Memorandum of Association or by these presents reposed in them.
190. Subject to the provisions of Article 190 but without prejudice to the general powers thereby conferred and so as not in any way to limit or restrict those powers and without prejudice to the other powers conferred by these presents, it is hereby expressly declared that the Directors shall have the following powers and authorities that is to say, power and authority :-
- a) to pay and charge to the Capital Account of the Company any commission or interest lawfully payable thereon under the provisions of Sections 40 of the said Act;

- b) to purchase in India or elsewhere any machinery, plant, stores and other articles and things, for all or any of the objects or purposes of the Company.
- c) to purchase, take on lease or otherwise acquire in India any lands, (whether freehold, leasehold or otherwise) and with or without houses, buildings, structures or machinery, (fixed or loose) and any moveable property, rights or privileges from any person including a Director in furtherance of or for carrying out its objects at or for such price or consideration and generally on such terms and conditions and with such title thereto as they may think fit or may believe or be advised to be reasonably satisfactory.
- d) to purchase, or otherwise acquire from any person and to resell, exchange and re-purchase any patent or license for the use of any invention and to purchase or otherwise acquire for the company and other property, formulae, concessions, rights and privileges which the Company is authorized to acquire, at or for such price or consideration and generally on such terms and conditions as they may think fit.
- e) in any such purchase or other acquisition to accept such title as the Directors may believe or may be advised to be reasonably satisfactory;
- f) at their discretion to pay for any property, rights or privileges acquired by or services rendered to the Company, either wholly or partly in cash or in shares or in both or in bonds, debentures, mortgages or other securities of the Company and any such shares may be issued either as fully paid-up or with such amount credited as paid-up thereon as may be agreed upon, and any such bonds, debentures, mortgages or other securities, may be either specifically charged upon all or any part of the property of the Company and its uncalled capital or not so charged.
- g) to sell for cash or on credit or to contract for the sale and future delivery of or to send for sale in any part of India or elsewhere any products or articles produced, manufactured or prepared by the Company as the Directors may deem advisable.
- h) to erect construct and build any factories, warehouses, godowns, engine houses, tanks, wells or other constructions, adapted to the objects of the Company as may be considered expedient or desirable for the objects or purposes of the Company or any of them;
- i) to sell from time to time any articles, materials, machinery, plant, stores and other articles and things belonging to the Company as the Directors may think proper and to manufacture prepare and sell waste and by-products;
- j) from time to time to extend the business and undertaking of the Company by adding to, altering or enlarging all or any of the buildings, factories, workshops, premises, plant and machinery for the time being the property or in the possession of the Company or by erecting new or additional buildings and to expend such sums of money for the purposes aforesaid or any of them as may be thought necessary or expedient
- k) to remove all or any of the machinery, plant and other moveable property of the Company for the time being in or upon lands, buildings or premises of the Company to other lands, buildings or premises.
- l) to negotiate for the subject to the approval of the Company in General Meeting contract for the sale and transfer of all or any part of the property and undertaking of the Company as a going concern subject or not subject to all or any of the obligations and liabilities of the Company.
- m) to undertake on behalf of the Company the payment of all rents and the performance of all covenants, conditions and agreements contained in or

reserved by any lease that may be granted or assigned to or otherwise acquired by the Company, and to purchase the reversion or reversions, and otherwise to acquire the freehold or fee-simple of all or any of the lands of the Company for the time being held under lease or for an estate less than a freehold estate.

- n) to improve, manage, develop, exchange, lease, sell, re-sell, and repurchase, dispose of deal with or otherwise turn to account any property (moveable or immovable) or any rights or privileges belonging to or at the disposal of the Company or in which the Company is interested.
- o) to secure the fulfillment of any contracts or engagements entered into by the Company by mortgage or charge of all or any of the property of the Company and its unpaid capital for the time being or in such manner as they may think fit.
- p) to accept from any member on such terms and conditions as shall be agreed upon and as far as may be permissible by law a surrender of his shares or any part thereof
- q) to determine from time to time who shall be entitled to sign on the Company's behalf, bills, notes, receipts acceptances endorsements cheques, dividend warrants, release, contracts and documents and to give the necessary authority for such purposes.
- r) to make advances and loans without any security or on such security as they may think proper, and to take security for already existing debts and otherwise to invest and deal with any of the moneys of the Company in Government or Municipal securities, fixed deposits in call or notice in banks, and in such other manner as they may think fit and from time to time to vary or realize such investments.
- s) to make and give receipts releases and other discharges for moneys payable to or for goods or property belonging to the Company and for the claims and demands of the Company
- t) subject to the provisions of Sections 179, 180, 181, 182, 185 and 186 of the said Act, to invest and deal with any money of the Company upon such security (not being shares of the Company) or without security and in such manner as they may think fit, and from time to time to vary or realize such investments. Save as provided in Section 187 of the said Act, all investments shall be made and held in the Company's own name.
- u) to give to any officer or other persons employed by the Company including any Directors so employed a commission on the profits of any particular business or transaction or a share in general or particular profits of the Company, and such commission or share of profits shall be treated as part of the working expenses of the Company, and to pay commissions and make allowances to any person introducing business to the Company or otherwise assisting or promoting its interest.
- v) subject to the provisions of Section 187 of the said Act to appoint any person or persons (whether incorporated or not) to accept and hold in trust for the Company any property belonging to the Company, or in which the Company is interested, or for any other purpose and to execute and do all such acts deeds and things as may be requisite in relation to any such trust, and to provide for the remuneration of such trustee or trustees.
- w) to insure and keep insured against loss or damage or fire or otherwise for such period and to such extent as they may think proper all or any part of the buildings, machinery, goods, stores, produce and other moveable property of the Company either separately or conjointly, also to insure all or any portion of the good, produce machinery and other articles imported or

exported by the Company and to sell, assign, surrender or discontinue any policies of assurance effected in pursuance of this power.

- x) to attach to any shares to be issued as the consideration or part of the consideration for any contract with or property acquired by the Company or in payment for services rendered to the Company, such conditions as to the transfer thereof as they think fit.
- y) to execute in the name and on behalf of the Company in favour of any Director or other person who may incur or be about to incur any personal liability for the benefit of the Company, such mortgages of the Company's property (present and future) as they may think fit and any such mortgage may contain a power of sale and such other powers, covenants and provisions as shall be agreed upon
- z) to institute conduct defend compound abandon or refer to arbitration, any action suit appeals proceedings, for enforcing decrees and orders and other legal proceedings by or against the Company or its employees or otherwise concerning the affairs of the Company to compound or compromise and allow time for payment or satisfaction of any debts due and of any claims or demands by or against the Company and to refer the same to arbitration to observe and perform any awards made thereon to act on behalf of the company in all matters relating to bankrupts and insolvents
- aa) the Secretary or any other person duly authorized by the Directors shall be entitled to make give sign and execute all and every warrant to sue or defend on behalf of the Company and all and every legal proceedings and compositions or compromise agreement and submission to arbitration and agreement to refer to arbitration as may be requisite and for the purposes aforesaid the Secretary or such other person may be empowered to use their or his own name on behalf of the Company, and they or he shall be saved harmless and indemnified out of the funds and property of the Company from and against all costs and damages which they or he may incur or be liable to by reason of their or his name so used as aforesaid
- bb) to provide for the welfare of the Director ex-Directors, employees or ex-employees of the Company and the wives and widows and families or the dependents or connections of such persons and to give award or allow any pension, gratuity compensation, grants of money allowance bonus or other payment to or for the benefit of such person as may appear to the Directors just and proper whether they have or have not a legal claim upon the Company, and before recommending any dividends to set aside portions of the profits of the Company to from a fund to provide for such payments and in particular to provide for the welfare of such persons by building or contributing to the building of houses dwellings or chawls or by creating and from time to time subscribing or contributing or contributing to provident and other association institutions funds or trusts and by providing or subscribing or contributing towards places of instruction and recreation hospitals and dispensaries medical and other attendance and other assistance as the Directors shall think fit and to subscribe or contribute to or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, political, national, or other institutions, parties, objects, or funds which shall have any moral or other claim to support or aid by the Company either by reason of locality of operation or of public and general utility; The Director shall duly comply with Sections 293 and 293A, of the Act;
- cc) before recommending any dividend to set aside out of the profits of the Company such sums as they think proper for depreciation or as reserve or as loss to a Depreciation Fund, Reserve or Sinking fund or any special fund to meet contingencies or to repay debentures or debenture stock or to pay off

preference or other shareholders subject to the sanction of the Court when the same is required by law or for payment of dividends or equalizing dividend or for special dividend or bonus or for repairing improving, extending and maintaining any part of the property of the Company and for such other purpose (including the purposes referred to in the preceding clause) as the Directors may in their absolute discretion think conducive to the interest of the Company and from time to time to carry forward such sums as may be deemed expedient and to invest and deal with the several sums so set aside or any part thereof as provident in clause q of this Article as they think fit and from time to time to deal with and vary such investment and dispose of and apply and expend the same or any part thereof for the benefit of the Company in such manner and for such purpose as the Directors in their absolute discretion think conducive to the interest of the Company notwithstanding that the matter to which the Directors apply or upon which they expend the same or any part thereof may be matters to and upon which the capital money of the Company might rightly be applied or expended and the Directors may divide the Reserve or any Fund into such special funds and transfer any sum from one fund to another as they may think fit and may employ the assets constituting all or any of the above funds including the Depreciation Fund or any part thereof in the business of the Company or in the purchase or re-payment of debentures or debenture-stock or preference share or in payment of special dividend or bonus and that without being bound to keep the same separate from the assets, and without being bound to keep the same separate from the assets and without being bound to pay interest for the same with power however to the Directors at their discretion to pay or allow to the credit of such funds or any of them interests at such rate as the Directors may think proper.

- dd) from time to time and at any time to entrust to and confer upon the officers for the time being of the Company and to authorize or empower them to exercise and perform and by Power-of-Attorney under seal to appoint any person to be the Attorneys of the Company and invest them with such of their powers authorities duties and discretions exercisable by or conferred or imposed upon the Directors but not the power to make calls or other powers which by law are expressly stated to be incapable of delegation as the Directors may think fit and for such time and to be exercised for such objects and purpose and subject to such restrictions and conditions as the Directors may think proper or expedient and either collaterally with or to the exclusion of and in substitution for all or any of the powers authorities duties and discretion of the Directors in that behalf with authority to such officers or attorneys to sub-delegate all or any of the powers authorities, duties and discretions for the time being vested in or conferred upon them and from time to revoke all such appointments of attorney and withdraw alter or vary all of such powers authorities duties and discretions;
- ee) to appoint and at their pleasure to remove discharge or suspend and to re-employ or replace for the management of the business a manager (subject to Section 166, 167 of the said Act read with Section 203) secretaries, experts, departmental, accounts, agents, sub-agents, bankers, brokers, mucedums, solicitors, clerks, servants, and others employees for permanent temporary or special services as the Directors may from time to time think fit and to determine their powers and duties and to fix their emoluments, salaries, wages and to require security in such instances and to such amount as they think fit and to insure and arrange for guarantee for fidelity of any employees of the Company and to pay such permission on any policy of guarantee as may from time become payable;
- ff) without prejudice as aforesaid and subject to the provisions of Section 179 of the said Act from time to time and at any time to establish any Local

Board for the affairs of the Company in any specified locality in India or elsewhere and to appoint any person to be members of any Local Boards and to fix their remuneration. And from time to time and at any time to delegate to any person so appointed any of the powers authorities and discretions for the time being vested in the Directors other than their power to make a call and to authorize the members for the time being of any such Local Board or any of them to fill up any vacancies therein and to act withstanding vacancy and any such conditions as the Directors may be made on such terms and subject to such conditions as the Directors may think fit and the Directors may at any time remove any person so appointed and may annual or vary any such delegation. Any such delegates may be authorized by the Directors to sub-delegate all or any of the powers authorities and discretions for the time being vested in him;

- gg) without prejudice as aforesaid at any time and from time to time by Power-of-Attorney to appoint any person or persons to be Attorneys of Company for such purpose and with such powers authorities and discretions (not exceeding those vested in or exercisable by the Directors under these presents) and for such period and subject to such conditions as the Directors may from time think fit and any such appointment (if the Directors think fit) may be made in favor of the members or any of the members of any Local Board established as aforesaid or in favor of any company of the members directors, nominees or managers of any company or firm or otherwise in favor of any fluctuating body or persons whether nominated directly or indirectly by the Directors and any such Powers-of-Attorney may contain such powers for the protection or convenience of person dealing with such Attorney as the Directors may think fit;
- hh) without prejudice as aforesaid from time to time to provide for the management and transaction of the affairs of the Company outside Bombay or in any specified locality in India or outside India in such manner as they think fit and specified locality in India in such manner as they think fit and in particular to appoint any person to be the Attorneys or agents of the Company with such powers authorities and discretions (including power to sub-delegate) but not exceeding those vested in or exercisable by the Directors and also not the power to make calls or issue debentures and for such period and upon such terms and subject to such conditions as the Directors may think fit and at any time to remove any person so appointed or withdraw or vary any such powers as may be thought fit and for that purpose the Company may exercise the powers conferred Sections 50 and 157 of the Act relating to official seal for use abroad and the keeping in any State or country outside India a foreign Register respectively and such powers shall accordingly vested in the Directors;

- kk) generally subject to the provisions of the Act and these Article to delegate the powers authorities and discretion vested in the Directors to any person firm, company or fluctuating body or persons as aforesaid.

XXV. DUTIES OF DIRECTORS

191. The Director shall duly comply with the provisions of the Companies Act 2013 or any other statutory modifications thereof for the time being in force and the Rules made there under and in particular the provisions in regard to registration of the particulars of mortgages debentures and charges affecting the property of the Company or creating by it and keeping a Register of Directors, Managers etc. and sending to the Register annual returns and an annual list of members and a summary of particulars relating thereto and the Balance Sheet and the notice of any consolidation or increase of share capital or conversion of shares into stock and the copies of Special Resolution and the Register of Directors, Managers, etc. and notifications of any change therein
- Directors to comply with statutory duties

XXVI. WHOLE-TIME DIRECTORS

192. I. Subject to the provisions of the Act and of these Articles, the Company in General Meeting shall have power to appoint from time to time one or more person to be Whole-time Directors of the Company for such period and upon such terms and conditions as the Company in General Meeting may think it. The Board shall have power (subject to the provisions of any contract between him or them and the Company) to remove or dismiss him or them from office.
- Company may appoint Whole-Time Directors
- II. The remuneration of Whole-time Director may be by way of a fixed monthly payment fee for each meeting or participation in profits or by any or all of these modes or any other mode not expressly prohibited by the Act.

- III. Subject to the superintendence control and direction of the Board and of the Managing Director, the Whole-time Director(s) shall carry out such duties as may be entrusted to him or them by the Board and the Managing Director.

XXVII. MANAGING DIRECTORS

193. Subject to the provisions of the Act and of these Articles, the Board shall have power to appoint from time to time one or more of their body to be a Managing Director or Managing Directors of the Company for such term not exceeding five years at a time and upon such terms and conditions as the Board may think fit and may from time to time (subject to provisions of any contract between him or them and the Company) remove or dismiss him or them from office and appoint another or other in his or their place or places. If approved by the Board of Directors the Managing Director be permitted to hold the position of both the Chairman of the Directors, Meeting as well as the position of Managing Director in the Company at the same time.
- Board may Appoint Managing Director
194. The remuneration of a Managing Director may be way of a fixed monthly payment fee for each meeting or participation in profits or by any or all these modes or any other mode not expressly prohibited by the Act.
- Remuneration of Managing Director

195. Subject to the superintendent control and direction of the Board of Directors the day to day management of the Company shall be in the hands of the Managing Directors. The Directors may from time to time entrust to and confer upon a Managing Director for the time being save as hereafter in this Article provided such of the powers exercisable under these presents by the Directors as they may think fit and may confer such powers for such time and to be exercised for such object and purposes and upon such terms and conditions and with such restrictions as they think expedient and may subject to the provisions of the Act and these Articles confer such powers of the directors in that behalf and may from time to time revoke withdraw after or vary all or any of such powers provided however that the powers entrusted to the Managing Director by the Board of Directors shall be subject to the provision of Section 179 of the Act. Power and Duties of Managing Director
196. A Managing Director shall not while he continues to hold that office be subject so retirement under Article 157. If he ceases to hold the office of the Director he shall ipso facto cease to be a Managing Director.

XXVIII. COMPANY SECRETARY

197. i. The Director may from time to time appoint a Company Secretary either for a fixed term or without any limitation as to the period for which he is to hold that office and may from time to time remove or dismiss him from office and appoint another in his place and fix the remuneration of such Company Secretary which may be by way of salary or commission or participation in profits or by any or all of these modes and may also from time to time appoint a temporary substitute for the Company Secretary who shall be deemed to be the Company Secretary during the term of his appointment. The Company Secretary may be one of the Directors of the Company. Directors may appoint Secretary
- ii. The Company Secretary for the time being shall exercise and perform all powers authorities, discretion and duties as conferred upon him under the Act and as may from time to time be vested in conferred upon or assigned to him by the Directors appointing him or by these presents.

XXIX. INDEMNITY TO AND PROTECTION OF DIRECTORS AND OFFICERS

198. Every officer of the Company as defined by Section 2(59) of the said Act or any persons (whether an officer of the Company or not) employed by the Company as Auditor shall be indemnified out of the funds of the Company against all liability incurred by him in defending any proceedings whether civil or criminal, in which judgment is given in his favor or in which he is acquitted or discharged or in connection with any application under Section 463 of the said Act in which relief is granted to him by the Court. Indemnity
199. Subject to the provisions of Section 197 of the said Act, every Director of the Company or the Manager or Secretary, Trustee, Auditor and other officer or servant of the Company shall be the duty of the Directors out of the funds of the Company to pay all losses, costs, and expenses which any such person officer or Indemnity to Directors and other Officers

servant may incur or become liable to by reason of any contract entered into or any act or thing done by him as such officer or servant or in any way in or act about the discharge of his duties including travelling expenses.

200. Subject to the provisions of Section 197 of the said Act no director of the Company or Secretary, Trustee, Auditor and other officer or servant of the Company shall be liable for the acts, receipts, neglects or defaults of any other Director or officer or servant or for joining in any receipts or other act for the sake of conformity merely or for any loss or expenses happening to the Company through the insufficiency or deficiency in point of titles or value of any property acquired by the order of the Directors for or on behalf of the Company or mortgaged to the company or for the insufficiency or deficiency of any security in or upon which any of the moneys of the Company shall be invested or for any loss or damage arising from the bankruptcy or tortuous act of any loss person, company or corporation to or with whom any moneys securities or effects of the Company shall be entrusted or deposited or for any loss occasioned by and error of judgment omission default or oversight on his part or for any other loss damage or misfortune whatever which shall happen in relation to the execution or performance of the duties of his office or in office or in relation thereto unless the same happen through his own dishonesty.
- Directors and other officers not responsible for acts of others.

XXX. THE SEAL

201. The Directors shall provide a Common Seal for the purpose of the Company and shall have power from time to time destroy the same and substitute a new Seal in lieu thereof and the Directors shall provide for the safe custody of the Seal for the time being. The Seal shall never be used except by the authority of the Board of Directors or a Committee of the Board authorized by it in that behalf.
- The Seal and its custody and use.
202. Every deed or other instrument to which the Seal of the Company is to be affixed shall be sealed in the presence of one Director who shall sign the same and in the presence of the Secretary or such other person as the Directors may for the purpose from time to time appoint who shall sign the same. Save that the Directors shall as regards affixing the Seal on the share Certificate comply with the provisions of the Rules issued in that behalf under the Act.

203. A person who holds any shares in or debentures of the Company as trustee shall comply with the requirements of Article 23.

XXXII. SECRECY CLAUSE

212. No member shall be entitled to visit any works of the Company without the permission of the Directors of to require discovery of any information respecting any detail of the Company's working trading or any matter which is or may be in the nature of a trade secret mystery of trade or secret process which may relate to the conduct of the business of the Company and which in the opinion of the Directors, it will be inexpedient in the interest of the members of the Company to communicate to the public. 213. XXXIII WINDING UP

214. If upon the winding up of the Company the surplus assets shall be more than sufficient to repay the whole of the paid-up capital, the excess shall be distributed amongst the members in proportion to the capital paid or which ought to have been paid on the shares at the commencement of the winding up held by them respectively other than the amounts paid by them in advance of calls.
