SUMMARY OF THE PROCEEDINGS OF 41st ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

The 41st Annual General Meeting of the Company was held on Monday, 25th September 2023 at 11.30 AM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Sanjay Mishra, Chairman & Managing Director of the Company occupied the chair.
- Total 66 members including one member from Promoter group were present in the meeting.
- As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 41st AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 41st AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 41st AGM was provided to the Members of the Company from 9.00 am on 22nd September 2023 and up to 5.00 pm on 24th September, 2023 and that the e-voting module was closed by NSDL thereafter.
- 5 Speakers have registered themselves as speakers in the meeting and the queries raised by 3 of them have been suitably replied. The queries raised by Speakers were related to future prospectus, development of business as well as about Right Issue, which has been announced by the Company earlier. Thereafter the Chairman requested to all those Members who had not voted through remote e-voting till the time, to vote through the e-voting process provided at the AGM. Mrs. Kriti Daga,



Practicing Company Secretary was appointed as Scrutinizer for scrutinizing the remote e-voting and e-voting at the AGM.

• The following items of business as set out in the notice convening 41st AGM were placed for members' consideration and approval.

RESOLUTION(S)

Ordinary Business:

- i. the Audited Standalone Financial Statements of the Company for the financial year ended 31st March, 2023 and the Reports of the Board of Directors and Auditors thereon; and
- ii. Re-appointment of Mr. Sanjay Mishra (DIN: 09048557) who was retired by rotation and was eligible for re-appointment.

Special Business:

- iii. Appointment of Statutory Auditors on expiry of terms of services for current Auditors;
- iv. Appointment of Mr. Sanjay Mishra (DIN: 09048557) as a Chairman & Managing Director of the Company for the period of 5 Years;
- v. To ratify the member's resolution passed on April 28, 2023 for appointment of Mrs. Sudipta Bhattacharya (DIN: 09708283) as an Independent Director;
- vi. To ratify the member's resolution passed on April 28, 2023 for appointment of Ms. Haimonti Das (DIN: 09705524) as an Independent Director;
- vii. To Borrow funds in excess of the limits provided under section 180 (1)(c) of the Companies Act, 2013;
- viii. To mortgage / create charge on the assets of the Company as a security towards borrowings;
- ix. To approve transactions under Section 185 of the Companies Act, 2013; and
- x. Approval for investments/ Loans/ Guarantees/ Securities under section 186 of the Companies Act, 2013.
- The Chairman thereafter informed that the Result of the voting will be declared after counting of votes cast through e-voting during the AGM and votes cast by remote e-voting prior to the AGM as per the report of the Scrutinizer and that the results of the voting will be intimated to the Stock Exchanges and also uploaded on the website of the Company in due course of time.
- The meeting concluded with a vote of thanks to the Chair at 11.55 AM.

VOTING BY MEMBERS:

• The Company had provided remote e-voting facility to its members to cast votes electronically on both items of business set out in the Notice.



 Further, the facility to vote on resolutions through electronic voting system at the meeting was made available to the members who participated in the meeting and had not cast their votes through remote e-voting.
